**PROCESSING OF PERSONAL DATA**

**1. DATA CONTROLLER**

Your personal data may be processed by Zeren Group Yatırım Holding Anonim Őirketi ("Company") as data controller in accordance with the Law No. 6698 on Protection of Personal Data ("Law") as described below.

You can access detailed information regarding the processing of your personal data by our Company from the Zeren Group Investment Holding Joint Stock Company's Personal Data Protection and Processing Policy, which has been shared with the public at the address of **Zeren Group PERSONAL DATA PROTECTION AND PROCESSING POLICY.**

**2. PURPOSE OF PROCESSING PERSONAL DATA**

Your collected personal data can be processed, in accordance with the basic principles stipulated in the Law and within the personal data processing conditions specified in Articles 5 and 6 of the Law, especially for the purpose of fulfilling our obligations arising from the Law No. 5651 as a collective provider and ensuring access and monitoring of the visitor internet network,

- Planning and / or execution of the activities of the legal and technical security of our company and the persons who have a business relationship with our Company.

**3. PARTIES PERSONAL DATA ARE TRANSFERRED TO AND PURPOSE OF TRANSFER**

Your collected personal data may be transferred to our business partners, suppliers, legally authorized public institutions and authorized private persons in line with the realization of the Objectives in accordance with the personal data processing conditions specified in Articles 8 and 9 of the Law.

**4. METHOD OF COLLECTION OF PERSONAL DATA AND LEGAL REASON**

In case you contact your company, your personal data is collected electronically via SMS and our wireless internet connection channels.

In addition, your personal data are collected on the basis of legal obligations and the legitimate interests of legal obligations regulated in Articles 5 and 6 of the Law.

## **5. YOUR RIGHTS AS A PERSONAL DATA SUBJECT STUPLATED THE ARTICLE OF 11 OF THE LAW**

As a personal data subject, we'd like to inform that you have the following rights in accordance with Article 11 of the Law:

- To learn whether personal data is processed or not,
- If the personal data are processed, to request information about it,
- To learn the purpose of his data processing and whether this data is used for intended purposes,
- To know the third parties to whom personal data are transferred domestically or abroad,
- To request rectification of personal data in case of incomplete or incorrect processing, and requesting notification of the transaction performed within this scope to third parties to whom personal data has been transferred,
- Despite the fact that it has been processed in accordance with the provisions of the Law and other relevant Laws, to request the erasure or destruction of personal data in case the purpose requiring its processing does not exist and to request informing the third parties to whom the personal data has been transferred,
- To object to the processing, exclusively by automatic means, of his personal data, which leads to an unfavorable consequence for the data subject,
- To request the compensation of the damage raising from the unlawful processing of his personal data.

You can send your applications regarding your rights listed above to our Company by filling out the Zeren Group Yatırım Holding Anonim Şirketi Data Subject Application Form, which you can access from the address of **Zeren Group DATA SUBJECT APPLICATION FORM.** Depending on the nature of your request, your applications will be concluded free of charge as soon as possible and within thirty days at the latest; however, if the transaction requires additional cost, you may be charged according to the Schedule to be determined by the Personal Data Protection Board.
